We respect data privacy rights and are committed to protecting the personal information collected on this Website. This privacy policy **("Privacy Policy")** sets forth *how we collect, use and protect the personal information* collected on this Website.

#### 1. COOKIES AND TRACKING TECHNOLOGIES
